COMMUNITY EMERGENCY & RESILIENCE PLAN

This plan is adapted from a template provided by the Emergency Planning Service of Dorset Council.

- **1. Purpose**: The purpose of the plan is to provide a self-help guide to the resources available within the community to support it in a crisis, and the particular procedures to be followed for specific crisis, especially if the emergency services or relevant local authority support is delayed due to thescope and nature of the emergency.
- **2. Resources Available to the Community**: A list of resources potentially available within the community should be compiled by each coordinator.
- **3. Useful Contact Numbers**: A list of other relevant contact numbers and web sites for the emergency services, local authorities and other relevant organisations is attached.
- **4. Telephone Tree:** Each coordinator is encouraged to identify a small number of people within their area who can be called upon to help in the event of an emergency, and keep their telephone numbers readily available.
- **5.** Courier Service: It would be good if each coordinator could be aware of the homes of the other coordinators close to them, and of the lead coordinator, in order for contact to be made if phone and internet are not available.
- **6. Vulnerable People**: There are a number of groups of people who, in a crisis, should be considered as potentially vulnerable:
 - a. People with mobility limitations, both young and old.
 - **b.** Disabled people (including physical disability and learning disability).
 - c. Blind and partially sighted people.
 - d. Parents who are on their own with children under 12.
 - **e.** Anyone in charge of a group of children when the incident happens e.g. playgroup staff, Guide and Scout leaders.
 - **f.** Newcomers to the parish who may not know all its facilities.
 - **g.** Hearing impaired people. It should also be noted that people who are deaf or hard of hearing may not be aware of broadcast alerts, and may need a personal visit to ensure they know of any risks to which the community is being alerted.

ROLE OF PARISH COUNCIL AND LOCAL COMMUNITY

Nearly all emergencies affecting communities will be dealt with routinely by the joint response of the emergency services, local authorities and the major utility companies with support from the Voluntary Sector. However, there may be occasions when circumstances (such as extensive flooding, storm damage or deep snow) delay the arrival of external assistance and the community will need to help itself until any necessary wider response can be assessed, coordinated, and deployed. For Charmouth, the arrangements are set out below:

1. Community Response. Charmouth Parish Council will activate a Community Response Group (CRG) when notified of the need for an emergency response. The following are key contacts and can act as CRG leads:

2. Activation. On notification of an emergency, the CRG Lead will contact appropriate key organisations in the area to activate the community response, and establish an Emergency Muster Point (EMP) from the following:



3. Activation Procedure:

- Activate GRG via WhatsApp
- CRG Lead to contact emergency services, 999, and follow any advice given. Establish communication link and provide local knowledge.
- CRG Lead to contact Dorset Council Emergency Planning Team and follow any advice given.
- Contact Dorset Incident hotline 0800 807060
- Record advice and actions from the emergency services and Dorset Council Use Incident Log sheet.
- Contact other members of the Parish Council (WhatsApp Group Parish Councilor Emergency Alert) to notify them the Community Resilience Plan is activated; help is needed and to meet at Emergency Muster Point.

POSSIBLE TYPES OF RISK

The following are the issues we are likely to have to face in Charmouth which might trigger an emergency response.

- 1. FLOOD When we get a flood warning from EA.
- 2. SNOW When we receive alert from Met Office.
- 3. OTHER EXTREME WEATHER EVENT When we receive an alert from Met Office.
- 4. PANDEMIC When we receive a health warning.
- 5. LOSS OF UTILITIES When electricity, gas, water is lost.


SEWAGE PUMPING STATION AND TREATMENT WORKS

The sewage pumping station is located off the pathway that connects Lower Sea Lane and the footbridge over the River Char. The sewage piping network in Charmouth collects sewage at this pumping station, then pumps the sewage up to the sewage treatment works (north of the field used for the Monday market). The sewage is then treated and then flows back down to the foreshore for it to discharge out to sea some 600m off shore.

The Sewage Treatment Works is located at Catherston Lane, DT6 6QZ (Easting: 337170.33, Northing: 93707.48). The plant is operated by Wessex Water.

RESPONSE TO FLOODING

- **2. General:** The risk associated with flooding in Charmouth may directly affect private properties, but more concerned with restricting access if roads are flooded and impassable. So far as can be seen from the Environment Agency's map, as below some parts of the parish could be completely cut off by flooding.
- 3. EA Flood Maps: Key to map on next page.



4. Sandbags. If sandbags are required, contact Charmouth Parish Council on 01297 560826. The Parish Council will assist with distribution according to available capacity. Sandbags stored at local Fire station. Key holders David Humphreys, Judith Sheppard, Katie Moore.

| 1 | Sewer drains near Seadown Holiday Park | Sewer drains | New pump at Seadown appears to be helping now. |
| 2 | The Street Catherston Cottages River Cottages Bridge House Kingfisher Caravan Sales and House | Charmouth Stream | After extremely heavy rainfall the Charmouth Stream can flood in 2 hours 30 minutes. High tides can cause water to back up on the River Char. |
| 3 | Seadown Holiday Park | River Char | High tides can cause water to back up on the River Char. |
| 4 | Manor Farm Holiday Park | Charmouth Stream River Char | After extremely heavy rainfall the Charmouth Stream can flood in 2 hours 30 minutes. After extremely heavy rain and high tides River Char can overflow downstream from Dolphins Holiday Park and flood into fields alongside Manor Farm. |
| 5 | Mill Cottages | Charmouth Stream | After extremely heavy rainfall the Charmouth Stream can flood in 2 hours 30 minutes. |
| 6 | Heritage Coast Centre/Car Park | Tidal and Fluvial | Close if required. |
| 7 | Bridge Road | Tidal and Fluvial | Little risk of these properties experiencing flooding, but they may like to be kept informed of the situation as water may come into their gardens. |
